


Fig. 1 - Typical voltage transfer characteristics.




Fig.2 - Typical power dissipation vs. frequency.






Fig.3 – Typical output low (sink) current characteristics.




Fig. 6 - Schematic and logic diagrams for CD4002B.




Fig. 7 - Schematic and logic diagrams for CD4025B.







Fig. 8 - Typical output high (source) current characteristics.


